Elliot asked how many times a week the company will clean. Wilken stated they have once a week, biweekly, or once a month. Elliot stated the buildings are used by several people throughout the day. Wilken stated he thought someone was speaking to Patsy before the next meeting. Wilken made a motion to table the hiring of a village cleaner. Ahlman seconded the motion. Old Business

Ordinance

1. Ordinance No. 516 Village Employee Wages

Ordinance No. 516, an Ordinance of the Village of Greenwood, Cass County, Nebraska, to provide for the wages and salaries of certain officers, appointees, elected officials and employees of the Village of Greenwood, Nebraska; To provide definitions; to provide for the severability of any section, clause, provision



or portion found unconstitutional or invalid; to repeal all ordinances in conflict herewith; to provide that this ordinance shall be published either in pamphlet form or by posting; and to provide that this ordinance shall not be made a part of the municipal code of the Village of Greenwood, Nebraska, was introduced by Wilken. The Chairman then instructed the Clerk to read Ordinance No. 516 of the Village of Greenwood, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 516 by title.

Wilken made a motion to approve Ordinance No. 516. Mack seconded the motion. Roll call vote: All ayes. Motion caried.

Wilken made a motion to wave the second and third readings of Ordinance No. 516. Mack seconded the motion. Roll call vote: All ayes. Motion carried.

Wilken made a motion to adopt Ordinance No. 516. Mack seconded the motion. Roll call vote: All ayes. Motion carried.

Board Questions or Comments- Mack stated the permit for small animals should be raised. Gerlach stated absolutely no roosters are allowed within the Village limits. Mack stated the shelf outside the office is a hazard to small children. Gerlach stated the intersection at 7th and Walnut has pavement breakup. Break up on Church Road by the cemetery and he will call the county. Gerlach also stated the firehall floors should be cleaned by the gentleman from before. Gerlach also stated land for sale on the corner of town should be looked into for zoning. Wilken stated Greve has applied for a Grant from the government for covid relief funds.
