Ordinance

1. Approve/Disapprove Ordinance 517 Employee Wages

Ordinance No. 517, an Ordinance of the Village of Greenwood, Cass County, Nebraska, to provide for the wages and salaries of certain officers, appointees, elected officials and employees of the Village of Greenwood, Nebraska; To provide definitions; to provide for the severability of any section, clause, provision or portion found unconstitutional or invalid; to repeal all ordinances in conflict herewith; to provide that this ordinance shall be published either in pamphlet form or by posting; and to provide that this ordinance shall not be made a part of the municipal code of the Village of Greenwood, Nebraska, was introduced by Wilken. The Chairman then instructed the Clerk to read Ordinance No. 517 of the Village of Greenwood, Nebraska. The Clerk thereupon read the aforesaid Ordinance No. 517 by title.
