- 7. Discussion electrical for south end of park
- Wilken spoke to Jason Strode who is the Village lineman and he said he can put in a J Box. Then they will need an electrician to come in and run the wire. The wire will run underground. This will clean up the transformer as well Wilken stated. Wilken stated we needed to do whatever it takes to get the grant completed and get it done. Wilken stated we will get ahold of Jason and get a plan together for the next meeting.
- **8.** Approve/Disapprove electrical/lighting upgrade for ballfield and concession stand areas The lights are \$1,415 a light not including the poles Gerlach stated. Gerlach stated they would need 32 lights. This is a requirement for any legal night games. Gerlach stated this is a wish list item for the Parks and Rec committee. Kubik stated the Park and Rec is wanting to draw games in from other local towns. Kubik asked if this is the direction Greenwood is headed? Mack asked who would be in charge of all of this? Wilken stated they are willing to listen to Park and Rec if they are wanting things to update the Park. Kubik made a motion to table for further research and more actuals and motivation to move forward. Gerlach seconded the motion. Roll Call vote: Ayes-Wilken, Gerlach, Mack, Kubik. Motion carried.
